Your Acceptance

BY USING AND/OR VISITING THIS WEBSITE (collectively, including all Content available through the ZeitBrite.org domain name, the "ZeitBrite Website", or "Website"), YOU SIGNIFY YOUR ASSENT TO BOTH THESE TERMS AND CONDITIONS (the "Terms of Service") AND THE TERMS AND CONDITIONS OF ZEITBRITE'S PRIVACY POLICY, AND WHICH ARE INCORPORATED HEREIN BY REFERENCE. Assignment

General

You agree that: (i) the ZeitBrite Website shall be deemed solely based in Hawaii; and (ii) the ZeitBrite Website shall be deemed a passive website that does not give rise to personal jurisdiction over ZeitBrite, either specific or general, in jurisdictions other than Hawaii. These Terms of Service shall be governed by the internal substantive laws of the State of Hawaii, without respect to its conflict of laws principles. Any claim or dispute between you and ZeitBrite that arises in whole or in part from the ZeitBrite Website shall be decided exclusively by a court of competent jurisdiction located in the City & County of Honolulu, Hawaii.
